Part A: An introduction to the aifc

Why aifc

The Australian Institute of Family Counselling Limited (aifc) is one of the pioneers of counselling in Australia and is a professional training organisation engaged solely in counselling and family therapy training. Its primary objective is to transform lives to transform communities. One way we do this is by offering superior counselling training at reasonable cost to the Christian community. As a multi- denominational organisation, we are not connected with any specific Christian denominational structure. The organisation administration is operated through the aifc National Office in Canberra, with training centres in Brisbane, Melbourne, Perth and Sydney. In addition, we offer Online Supported Mode (including overseas students). Intensive teaching seminars are conducted in well-equipped venues providing excellent professional services. Regional Directors have been trained and appointed to conduct the course in their respective local centres.

aifc is committed to multiplication and in late 2007 helped launch the Ugandan Institute of Family Counselling (UIFC) based on the aifc program. aifc continues to assist UIFC in running their courses.

aifc is an independent public company limited by guarantee registered under the Corporations Act 2001. It is also a registered training organisation (RTO) with Australian Skills Quality Authority (ASQA), registered provider number 88037. An advisory panel of industry experts advise the aifc Training Committee. aifc meets the Standards for Registered Training Organisations (RTO) 2015 established by the National VET Regulator (NRV), competency based training of the ASQA, and the requirements of the VET Provider Guidelines of the Australian Department of Education and Training.

A brief history

In the early 90s, Dr Bruce and Nellie Litchfield found themselves fielding increasing requests from church leaders to deliver seminars on Christian counselling. They had both been through their own journey of brokenness and renewal, which had prompted them to complete counselling studies, and they had started to share what they had learnt from their years as Marriage and Family Therapists. By 1992, after several years of intense work, both in Australia and in the USA, and spurred on by a deep God-given passion for the health and restoration of individuals and families, the seminars were expanded and formalised into short course training.

Two years later, the program was brought under the banner of Family Ministries, Youth With A Mission (YWAM) and accredited as an Advanced Certificate in Christian Counselling and Family Therapy. Then, with additional development, in 1997 the courses were accredited as a Certificate IV and Diploma in Christian Counselling and Family Therapy.

Through restructuring, in 1999, the courses were transferred to the Family Resource Centre Australia, Institute for the Nations (YWAM) Canberra (the local expression of YWAM's international University of the Nations); but due to its remarkable growth, in 2001 the study program was taken out of YWAM and given its own identity as the newly formed Australian Institute of Family Counselling Limited.

In 2003, the Diploma was upgraded to an Advanced Diploma of Counselling and Family Therapy (Christian), and in 2010, a three year Vocational Graduate Certificate (VGC) in Counselling and Family Therapy (Christian) was introduced; which was later replaced by the Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual).



aifc now delivers Seminar Blended Modes Australia-wide through centres in Brisbane, Melbourne, Perth and Sydney. We also offer an Online Supported Mode program for students who are unable to attend training via study centres.

aifc co-founder, Dr. Bruce Litchfield passed away on 2 July, 2018.

Vocational Education and Training (VET)

Through our courses you will be trained to counsel both Christians and non-Christians. aifc is a Registered Training Organisation (RTO), operating across Australia, under the jurisdiction of the Australian Skills Quality Authority. As an RTO we are required to be compliant with all components of the Vocational Education and Training (VET) Quality Framework:

Course structure

The VET courses that will be offered to students in 2019 are:

- CHC51015 Diploma of Counselling
- 10487NAT Advanced Diploma of Counselling and Family Therapy (Christian)
- 10134NAT Graduate Diploma in Counselling and Integrated Psychotherapy (Spiritual)

The overall flow of the aifc courses is to teach a general model of Christian counselling in the Diploma, a model of Family Therapy in the Advanced Diploma (integrating theology, psychology and spirituality), and an intensive practical application with specialised counselling, psychotherapy and leadership skills in the Graduate Diploma.



CHC51015 Diploma of Counselling

The Diploma of Counselling equips you with the basic knowledge and people helping skills required in professional counselling. Incorporating a Christian worldview throughout, this course prepares you to work with clients using established counselling modalities whilst considering theological, psychological and spiritual dimensions to people's problems. There is a deliberate focus on students' personal and spiritual development and equipping as foundational before being able to help others. In the first semester of the course, Diploma students are encouraged to undertake their own personal counselling with an Advanced Diploma Student. This involves meeting with an Advanced Diploma student for seven x 1 hour sessions during the first 6 months of the course.

The Diploma is nationally-accredited, developed to agreed industry standards, and responsive to the current and future demand for counselling skills – both within the local church and in the broader Australia society. You will learn essential communication, micro-counselling, interviewing and intervention skills that will equip you to be an effective counsellor in a number of settings, including faith communities, not-for-profit organisations, community health centres, education agencies and government departments.

This course is offered via seminar blended mode and online supported mode.

The information below is for Part Time Students who commenced this qualification in 2018.

The Diploma prepares you to informally assist others. You will learn to fulfil the primary command of Jesus, which is to love God and love others. You won't just grow in your knowledge of counselling skills, Diploma graduates are also equipped to be a well–trained friend and discerning listening ear. Many students also go through transformational change personally and in their relationship with Jesus. You will learn that reconciliation through forgiveness and understanding Christian identity is essential. Applying these principles in your personal life enables you to understand how to provide this for others.

These foundational characteristics enable Diploma students to be of enormous assistance in church communities, provide family relationship assistance, and the skills developed are transferable to any workforce. The Diploma is essential in equipping students in the helping ministry and is a pre-requisite for the Advanced Diploma.

10487NAT Advanced Diploma of Counselling and Family Therapy (Christian)

The Advanced Diploma deepens the work already completed in the Diploma of Counselling and leads to over 20 hours of one-on-one counselling, where essential skills in listening, empathy and building trusting relationships are taught and assessed.

We develop a specific model of counselling, including systems theory, working with families and several electives that are essential for a well-rounded and comprehensive counselling qualification. Individual therapy, family therapy, stress management, case management, grief and addictions are explored and assessed in practical and easy to understand ways, whilst being incorporated into the aifc Family Therapy Model. You will begin your outward focussed journey in counselling via one-on-one sessions with clients and you can explore a number of elective units to suit your personal circumstances and calling. Depending on your Association membership at the successful completion of the Advanced Diploma, you can begin attracting clients and be paid according to PACFA and/or ACA guidelines. Students are given comprehensive knowledge and skills throughout the course and opportunities to work with clients under professional qualified supervisors.

This course is offered via seminar blended mode and online supported mode.

Practical hours

To complete the Advanced Diploma of Counselling and Family Therapy (Christian), a certain number of counselling hours must be completed. These hours relate to specific units. Some elective units also require counselling hours, thus students may be required to complete more than the minimum, depending on the electives that are undertaken.

For aifc purposes, counselling is defined as an intentional, professional relationship between two people, one of whom is the helper and the other is seeking help, which includes an expectation of confidentiality and therapeutic benefit.

All counselling hours in the Advanced Diploma must be conducted face to face with the counsellor and client present in the same room. Under special circumstances the Regional Director may grant a small percentage of the sessions to be conducted face to screen, however this should be avoided where possible.

All individual counselling sessions must be undertaken with an individual over the 18 years of age. aifc does not provide student placements or internships for these hours. However, we do have relationships with some organisations and counselling clinics that are often willing to take aifc students as counsellors during their training. Local staff members may provide the details of these organisations.

Prior to the commencement of the first counselling session, a Pre-counselling Hazard Checklist (found in the Student information/Student Forms section in Moodle) must be completed for each location in which you conduct any counselling. This will need to be uploaded to the Student Records on Moodle.

To fulfil ethical requirements all counselling hours must be accompanied by professional supervision. For every 4 hours of client counselling, students must complete 1 hour of Professional Supervision. In addition, current working with children check, professional counselling indemnity insurance and membership of a counselling association are required before counselling may commence in semester one. WWCC, supervision, insurance and association membership will be obtained at the student's own cost.

Membership of a Counselling Association

All students are required to register with one of the counselling governing bodies, either the Australian Counselling Association (ACA) or a member organisation of the Psychotherapy and Counselling Federation of Australia (PACFA) such as the Christian Counsellor's Association of Australia (CCAA) at the start of the Advanced Diploma before you conduct any counselling. There are no restrictions on the Counselling Association that students can join.

Upon successful completion of the 10486NAT Diploma of Counselling (Christian) students are eligible to apply for Level 1 Membership with the Australian Counselling Association (ACA) and any external counselling hours that you complete in the second semester will go towards toward professional registration recognition. Note that Advanced Diploma Students cannot join ACA at student level, rather they must join at Level 1.

Upon successful completion of the 10486NAT Diploma of Counselling (Christian) students are eligible to apply for Diploma Member with CCAA. It is important to note that at membership level students may not advertise his



or her counselling services in the CCAA website or publicly advertise him- or herself as a professionally qualified counsellor who is a CCAA member. Client contact hours and supervision hours shall not contribute to the client contact and supervision requirements for Graduate or Clinical membership, but it will contribute to client contact and supervision requirements for Provisional membership.

Ongoing Professional Development

Students will need to attend at least one hour of Professional Development to meet the course requirements of the Advanced Diploma. The CCAA offers Christian based training in each state and information can be found on their website.

Professional Counselling Indemnity Insurance

Students are required to have their own professional indemnity and public liability insurance before any therapy is undertaken in the Advanced Diploma. There are no restrictions to the insurance broker that you use and some companies are listed below.

Note that some insurance policies are limited to your level of counselling association membership, and/or do not cover student counsellors and this should be investigated before purchasing any policy. For example: PACFA Master Insurance Policy (included in student membership), this is acceptable for the first 6 months of the Advanced Diploma, however this insurance policy does not cover students for the second half of the Advanced Diploma where external clients are being seen.

Supervision

1. Internal and External Supervision

In Semester one, the student's Advanced Diploma assessor will supervise students for units CFTMFT625A and CFTCFT691A, provided they have received training in clinical supervision.

In the second semester of the Advanced Diploma course, it is strongly preferred that clinical supervision be provided by a non-aifc trained supervisor. However, students can receive individual clinical supervision from any accredited aifc staff member provided that staff member is NOT their assessor, is interstate AND has the Regional Director's approval.

2. Group Supervision

Group supervision sessions run on behalf of aifc in the second semester and will be charged to students at the rate of \$50 per student for 1.5 hours. Staff running group supervision must be accredited supervisors.

3. Supervisor qualifications

In Second Semester of the Advanced Diploma, all individual supervisors must meet the following qualifications:

Having completed at least three years' clinical practice with a minimum of 300 client hours AND



- Level 2 or above with ACA for two years OR graduate member of CCAA or PACFA for two years OR equivalent AND
- Completed an ACA or PACFA approved supervision course OR equivalent AND
- Member of ACA supervision college or CCAA or PACFA approved supervision register OR equivalent and having regular supervision of their supervision and PD on supervision every year

Students will need to ensure that they have found a suitable Supervisor by the end of semester one and completed the Supervisor Contract which is located on Moodle.

4. Ratio of client hours to supervision hours

Students must maintain a supervision hour to client hours ratio of 1:4. Advanced Diploma students must not undertake more than 6 client hours between supervision sessions.

- A maximum of 1.5 hours can be group supervision
- A maximum of 1 hour can be telephone consultation for supervision
- Face to screen supervision is considered the same as person to person

5. Mandated clinical supervision hours over the duration of each course

In the second semester of the Advanced Diploma, regardless of full time or part time, students must have monthly supervisory sessions, or a minimum of 5 individual clinical supervision with the same supervisor. This starts in July and ends in November. Other supervisory hours necessary to maintain a 1:4 ratio can be completed through additional individual or group sessions.

6. Supervisors Report

All students must have their individual Supervisor complete the Supervisor Report and upload it to Moodle in the last two weeks of the year. This applies to both Full Time and Part Time students and must show that students have had 5 individual sessions as outlined by point 5 of this section.

Log of Counselling Hours

In order to facilitate students to track their counselling and supervision hours, students will keep an aifc log available to download from Moodle. It is also recommended that students use their member associations log to record their hours and professional development every year.

At completion of the term 4 students are required to provide a Statutory Declaration, declaring that the number of counselling and supervisions hours list on the Counselling Log is true and correct.

Cost

Course fees are invoiced on a per unit basis. For unit course cost and additional cost refer to page 28.



10134NAT Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual)

The Graduate Diploma provides an environment where students will develop in exercising influence and leadership in counselling and therapy, becoming experts in their field. aifc's aim is to train Christian counsellors who ethically and effectively integrate their faith and practice.

The Graduate Diploma is structured to have three specific goals for students including:

- 1. Enhance knowledge and skills of those already qualified in mental health or theology as a stand-alone professional development program.
- 2. Enhance the leadership ability of students in the counselling profession and the broader community.
- 3. Students who have completed the aifc Advanced Diploma or hold another undergraduate (or higher) qualification in a theology (e.g. Theology, Ministry, Christian Studies, Divinity) or mental health (e.g., Psychology, Counselling, Social Work) field, demonstrating competence in counselling skills, grief and ethics, are eligible for entry into the Graduate Diploma.
- 4. Fulfil industry standards by providing a pathway for PACFA accreditation.

You will learn advanced cognitive, technical and communication skills and enhance your ability to evaluate and apply well known empirically tested therapies. The units provide an opportunity to develop in previously learned areas and investigate new avenues of learning. Workshop interactions are a source of rich peer learning in addition to receiving training from experts in relevant fields.

Areas of focus such as self-care, supervision, and specialty electives ensure you receive advanced therapy skills and are equipped to build and maintain a healthy vocational life.

Pathways of the Graduate Diploma Course

The level and type of accreditation is dependent upon the entry pathway into the Graduate Diploma:

- Professional development students who enter based on an 10487NAT aifc Advanced Diploma of
 Counselling and Family Therapy and then complete the aifc Graduate Diploma (including all the required
 person-to-person training hours) are eligible to receive the Psychotherapy and Counselling Federation of
 Australia (PACFA) accreditation PACFA accreditation at Intern level. Note: students who completed
 their Advanced Diploma prior to 2015 will have to undertake specifically selected electives if they wish to
 achieve PACFA accreditation.
- Accreditation students who enter based on Bachelor (or Higher) qualifications in Spirituality or Mental Health who complete the aifc Graduate Diploma, may be eligible for membership with the Australian Counselling Association (ACA) - Level 1 membership with ACA or with the Christian Counsellors Association of Australian (CCAA) - Provisional Level 1 membership

PACFA is The Psychotherapy and Counselling Federation of Australia, a national peak body for counsellors and psychotherapists and for professional associations in the counselling and psychotherapy field in Australia. CCAA is a member of this peak body.

ACA is The Australian Counselling Association, a national progressive professional peak association of counsellors and psychotherapists.

Employment opportunities

Students who complete the Graduate Diploma as a stand-alone course are able to work in private practice as an accredited counsellor registered with the Australian Counselling Association.

Students who complete the Graduate Diploma following the aifc Advanced Diploma will have completed sufficient formal education to attain intern (and ultimately graduate and clinical) status with PACFA based on a three-year pathway of study. Some organisations require a minimum of three years training for employment in a counselling role.



Course outline

The course structure of the Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual) is below. It is required that students complete 8 core and 4 elective units for a total of 12 units. Units are offered in 4 terms per year, each of approximately 10 weeks' duration.

There are a variety of electives available to choose from depending on the pathway into the course:

- Students who have completed an aifc Advanced Diploma can choose any electives that they haven't already completed in their previous study with aifc from Group A (General) electives.
- Students who hold a qualification in a mental health field must complete Group C (Spirituality) electives plus any two from Group A (General) electives.
- Students who hold a theology qualification must complete Group B (Mental Health) electives plus any two from Group A (General) electives. Recognition of Prior Learning and Credit Transfer (RPL/ CT).

Seminar: Most core units in the Graduate Diploma commence with a one-day workshop delivery of the course content including role-play and modelling; as well as support, practical assessment and feedback. Additionally Students who wish to undertake any electives offered as part of the Advanced Diploma of Counselling and Family Therapy (Christian) have the option of joining these seminar sessions.

Online: Each of the workshops will also be accessible online which you may live-stream over the internet in real-time or access later via video.

Intensive: The course also involves multi-day workshops called Intensives. Units offered through intensives will not be offered online which means that you will need to travel to and participate in these intensives.

Action/Reflection: As part of your Graduate Diploma you will also be required to participate in Action/Reflection sessions at a homeless shelter, soup kitchen, women's refuge, or at a therapy group.

Recognition of Prior Learning and Credit Transfer (RPL/CT).

Entry into the Graduate Diploma requires prior completion of the aifc 10487NAT Advanced Diploma of Counselling and Family Therapy or a relevant undergraduate or postgraduate qualification. Whilst students can apply for Recognition of Prior Learning (RPL) for units in the Graduate Diploma, students cannot 'double dip' by using units from their entry course for RPL into the Graduate Diploma. However, if a student has completed units of study in addition to the entry course these may be considered for RPL application. For example, a Graduate Diploma applicant who has completed aifc's Advanced Diploma and a Bachelor of Theology is able to use either of these courses for entry. They can then use units from the other course for consideration of RPL. The RPL application kit is located on the aifc website and needs to be completed four weeks prior to the commencement of the course.

Practical hours and placements

In order to complete the Graduate Diploma, a certain number of counselling hours must be completed. These hours relate to specific units. Three of the core units require 10 hours counselling each so the minimum counselling hours' requirement is 30 hours. Some elective units also require counselling hours, thus students may be required to complete more than the minimum, depending on the electives that are undertaking. The first 75% of the minimum counselling hours in the Graduate Diploma must be conducted face to face with the counsellor and the client present in the same room. Under special circumstances the Regional Director may grant some additional sessions to be conducted face to screen, however this should be avoided where possible. Counselling hours in excess of the minimum may be completed through alternative contract means as approved by the Regional Director.

For aifc purposes, counselling is defined as an intentional, professional, formal relationship between two people, one of whom is the helper and the other is seeking help, which includes an expectation of confidentiality and therapeutic benefit. If you are unsure of whether your circumstances in an adjunct profession such as chaplaincy would enable you to fulfil these requirements, please speak to your Regional Director. Counselling sessions are measured in hours, the norm being one hour in duration however in certain circumstances can range from minimum of 30 minutes a session to a maximum of 2 hours.

Prior to the commencement of the first counselling session, a Pre-counselling Hazard Checklist (found in the Student information/Student Forms section in Moodle) must be completed for each location in which you conduct any counselling. This will need to be uploaded to the Student Records on Moodle.

To fulfil ethical requirements all counselling hours must be accompanied by professional supervision. For every **4 hours** of client counselling, students must complete **1 hour** of Professional Supervision with a maximum of 6 counselling hours between supervision sessions. In addition, current working with children check (WWCC), professional counselling indemnity insurance and membership of a counselling association are required **before**



counselling may commence. WWCC, supervision, insurance and association membership will be obtained at the student's own cost.

aifc does not provide student placements or internships for these hours. However, we do have relationships with some organisations and counselling clinics that are often willing to take aifc students as counsellors during their training. Local staff members may provide the details of these organisations.

In some units aifc asks students to make recordings using a Blackboard Collaborate training room with a link for their assessor to view.

Clearance to work with children

Students must provide proof of clearance to work with Children for the entire course. Evidence of this must be uploaded to Moodle. Clearance requirements differ between states and territories.

Students are required to have their own professional indemnity and public liability insurance before any counselling/therapy is undertaken. There are no restrictions to the insurance broker students use and some companies are listed below.

Some insurance policies are limited to the level of counselling association membership and this should be investigated before purchasing any policy.

Membership of a counselling association

All students are required to register with one of the counselling governing bodies, at the start of the Graduate Diploma **before** any counselling is conducted. This may be through either the Australian Counselling Association (ACA) or a member organisation of the Psychotherapy and Counselling Federation of Australia (PACFA) such as the Christian Counsellor's Association of Australia (CCAA) or PACFA direct at the start of the Graduate Diploma **before** any counselling is conducted. There are no restrictions on the Counselling Association that students can join.

Professional Development students who enter the Graduate Diploma with successful completion of the 10487NAT Advanced Diploma of Counselling and Family Therapy (Christian) are eligible to apply for Provisional Level 1 Membership with CCAA. Members holding this division of membership will not be able to advance to Graduate or Clinical membership unless they undertake further training that satisfies PACFA basic training requirements. A minimum

of 40 hours of face-to-face counselling or psychotherapy practice (client contact) with 10 hours of supervision (related to client contact) within or after training is required.

Accreditation students who enter the Graduate Diploma with a Bachelor (or Higher) qualifications in Spirituality or Mental Health are able to apply for Student Membership with ACA. Students who have graduated from an ACA Accredited Course of study at minimum Diploma Level may apply for Level 1 Membership.

Professional supervision

Professional Supervisors used with the course, must meet the following criteria:

- Completed at least three years' clinical practice with a minimum of 300 client hours AND
- Level 2 or above with ACA for two years OR graduate member of CCAA or PACFA for two years OR equivalent AND
- Completed an ACA OR PACFA approved supervision course OR equivalent AND
- Member of ACA college of supervisors OR CCAA or PACFA approved supervision register OR equivalent and having regular supervision of their supervision and PD on supervision every year

Clinical practice is defined as at least 100 hours counselling per year since qualification completed. Students will need to ensure that they have found a suitable Supervisor before commencing counselling sessions and completed the Supervisor Contract which is located on Moodle.

There is a required minimum number of hours of professional supervision over the duration of the course. Regardless of full time or part time, students must have monthly supervisory sessions, or <u>a minimum of 7 individual clinical supervision hours with the same supervisor</u> per year. Other supervisory hours necessary to maintain a 1:4 ratio can be completed through additional individual or group sessions. For every unit that requires 10 counselling hours, there is a requirement of 2.5 clinical supervision hours. These can be made up of a combination of individual and group supervision according to these guidelines:

- A maximum of 1.5 hours can be group supervision
- A maximum of 1 hour can be telephone consultation for supervision
- Face to screen (Skype etc) as a medium for supervision is considered the same as person to person

There is a requirement for the student's main supervisor to complete a supervision report twice in the course. For full time students the requirement is at the end of term 2 and 4.

Log of counselling hours

In order to facilitate students to track their counselling and supervision hours toward their professional registration, students will keep an aifc counselling and supervision log available to download from Moodle. The log will include a statuary declaration for students to sign. In addition, it is recommended that students use their member association's log to record their counselling and supervision hours and professional development every year.

Additional support mechanisms offered to students:

Mid-term study groups - students have the option to meet in the middle of each term under the guidance of an aifc trainer for support, extra learning and opportunities, assessment discussions, feedback and encouragement. These will be offered online.

Clinical Placements – Students may undertake clinical placement days that incorporate elements of co-therapy, individual client work, supervision, feedback and self-evaluation. Although there are no assessable tasks



associated with clinical placements, records of attendance are recorded in order to ensure students meet minimum requirements of 200 person-to-person training hours for PACFA accreditation. Students can minimise the number of clinical placement days they complete by attending more seminars, workshops, mid-term study groups and the like.

Course Entry Requirements

All students who wish to undertake training in an aifc VET program must:

- Obtain a Working with Children Check relevant to their state's legislative requirements (Advanced Diploma of Counselling and Family Therapy and Graduate Diploma of Counselling and Integrated Psychotherapy only).
- Be over 18 or have completed a Senior Secondary Certificate, and be willing to complete aifc's Student Support Questionnaire
- If you are otherwise eligible, want to access a VET Student Loan and have not completed your Year 12 Certificate or a Cert IV or above (in Australia), you will also be required to take a government prescribed LLN Assessment. For more information, please contact studentservices@aifc.com.au
- Applicants for the Advanced Diploma and Graduate Diploma must also meet admission requirements outlined in the 2014 PACFA Training Standards. These state that students entering an accredited course of study need to demonstrate self-awareness, a relational capacity, ethical

behaviour, and an ability to reflect on and learn from experience and feedback. An assessment of these requirements is made by aifc trainers and assessors throughout your training journey in earlier courses.

CHC51015 Diploma of Counselling

To gain entry to the CHC51015 Diploma of Counselling students are required to meet the following entry requirements:

- A Senior Secondary Certificate of Education or equivalent, or Mature Age (over 18 years and employment/life experience)
- Students may:
- Be seeking a career change and are seeking employment in a counselling role as listed above.
- Have experience in pastoral ministry and wish to further develop their counselling and pastoral care skills
- As the course is designed to train Christians, it is advantageous for students to have a genuine commitment to Jesus Christ and the Christian faith

Advanced Diploma of Counselling and Family Therapy (Christian)

To gain entry into 10487NAT Advanced Diploma of Counselling and Family Therapy (Christian), students are required to meet the following entry requirements:

- Essential entry requirements are a Senior Secondary Certificate of Education or equivalent, or Mature Age (over 18 years and employment/life experience).
- Successfully completed 10486NAT Diploma of Counselling (Christian) or equivalent. This qualification provides the essential knowledge and skills required by entrants, including those specifically related to the application of the aifc General Counselling Model.
- Proof of clearance to Work with Children.
- As the course is designed to train Christians, it is advantageous for students to have a genuine commitment to Jesus Christ and the Christian faith.
- It is recommended that students have sufficient relevant work experience to indicate likely success at this level of qualification in a job role involving:
- The self-directed application of knowledge with substantial depth in some areas
- The exercise of independent judgement and decision-making
- The application of relevant technical and other skills.

These requirements are assessed at the completion of 10486NAT Diploma of Counselling (Christian) for all students and assessed via observation and performance over the whole course. These requirements must be met before a student is able to gain entry into the 10487NAT Advanced Diploma of Counselling and Family Therapy (Christian).

It is recommended students be assessed for entry against the course Admission requirements outlined in section 1.1 of the Psychotherapist and Counselling Federation of Australia (PACFA) Training Standards (2014). These are assessed at the end of the 10486NAT Diploma of Counselling (Christian) course by the student's assessor via observation and performance of the student's progression throughout the whole course. Entry is open to participants regardless of gender, race or Christian denomination.

NOTE: Students must provide proof of clearance to Work with Children within the first 25% of completion of the course.

Clearance requirements differ between Australian states and territories. For example, Victoria (Working With Children check); Queensland (Blue Card); South Australia (Criminal History Check).

Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual)

Entrants to the 10134NAT Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual) must:



- Counselling
- be over 18 years of age; and
- meet the requirements of working with children in the relevant Australian State/Territory.
- Demonstrate competence through a recognised training program or recognition process in the following units:
 - o CHCCSL508B Apply legal and ethical responsibilities in counselling practice
 - o CHCCSL502A Apply specialist interpersonal and counselling interview skills AND
 - o CHCCCS017 Provide grief and loss support

AND

• Demonstrate competence through a recognised training program or recognition process, in the core units of competency from the 10487NAT Advanced Diploma of Counselling and Family Therapy (Christian) or equivalent.

OR

- Have undergraduate degree or higher qualification in Mental Health (e.g. counselling, psychotherapy, psychology, social work)
 OR
- Have undergraduate degree or higher qualification in Spirituality (e.g. Theology, Ministry, Divinity)
- Entrants should have:
- High level of language literacy and numeracy level sufficient to:
- Interpret complex documents and publish articles
- Communicate with unwell individuals regarding complex personal issues
- Have a range of emotional vocabulary to accurately describe a client's feelings

In order to comply with PACFA 2014 training standards students will be ineligible to enter this course if they lack fundamental human capacities such as:

- Self-awareness
- Capacity to relate to individuals or groups
- Ability to practice ethically
- Ability to learn from experience based on positive and challenging feedback.

For professional development students, those entering from aifc's 10487NAT Advanced Diploma of Counselling and Family Therapy (Christian) these capacities are assessed by trainers and Regional Directors at the completion of the aifc 10487NAT Advanced Diploma of Counselling and Family Therapy (Christian) through a recommendation to continuation interview process. For accreditation students, those entering from a recognised prior qualification, these capacities are assessed through the aifc 10134NAT Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual) application interview process.

Your progress through our courses

Diploma of Counselling

Cornerstone

<u>Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual)</u> Refined

Semester 1

You are no longer a student in training but a colleague doing professional development. We go on a journey of professional and personal refinement from counsellor to therapist, exploring new clinical approaches, grappling with contemporary ethical issues and learning specific leadership skills. Our guiding text is Daniel 11:33-35.

Lead

Semester 2

Through elective choices, professional practice and a research project, you are becoming a subject matter specialist in a particular therapy area. We take you through an externally accredited course to teach you to be a supervisor. Our guiding text is Judges 5:6-9.

Assessments

It is important that all courses offered under the Australian Qualification Framework have specific stages to assess skills, knowledge and application of skills and knowledge.

In order to ensure learners attain the necessary practical skills, the following evidence mechanisms are employed:

- Written assessment, e.g., short answer, research report, case study, documenting discussion with learning partner
- Learning Management System (LMS) enabled, e.g., forums, multiple choice questions
- Presentation, e.g., oral presentations on a counselling topic, power point
- Demonstration, e.g., observation of counselling skills either face to face or by video, simulated workplace activity
- Reflection, e.g., personal reflection on counselling skills efficacy, trainer and assessor guided reflection on personal bias, discussion with peers, goal-setting journal, therapy report
- Third party report, e.g., supervisor's report, placement reports, logbooks
- Recognition of Prior Learning according to aifc's Recognition of Prior Learning and Credit Transfer policies



The information regarding the number and kind of assessments for each subject unit will be presented on the Study Planner and on Moodle.

Students upload assessments to the Moodle platform according to the Study Planner for each term.

Students must submit assessments in an easy to read font, similar to Times New Roman or Calibri, double-spaced and using the APA referencing style. See Moodle for a guide to this style of referencing.

All written assessments require in-text citations of relevant referenced material with a Reference List at the end of the task in APA style. The correct citation is required even where the question provides a text for comment and whenever the answer relates to a text included in the reference list. References may include books, periodicals or journal articles, online sources or visual media.

Extension Request

Extensions can be granted throughout your studies for extenuating circumstances and to assist you in this progress students will be asked to complete and online form prior to the due date. A notification is sent to your assessor for approval. Assessors can approve up to 3 days extension, anything over this timeframe approval will be determined by the Regional Director who may request additional information such as a medical certificate. If you do not request an extension you may be liable for an Administration Fee.

This link will be sent to you at the commencement of each term.

Further to this, students who struggle to meet due dates may be placed on a Support Plan to ensure both the trainer and student are clear in their responsibilities.

Volume of Learning

To meet the Volume of Learning requirements for each course, students will be required to complete a Learner Workbook for each unit. The Learner Workbook contains learning content, learning activities and reading reflection activities.

Professional recognition of aifc's courses

aifc offers some of the few counselling courses that are recognised by the Australian Counselling Association (ACA) and the Psychotherapist and Counselling Federation of Australia (PACFA). Each of these organisations has different standards that must be met. Where these standards conflict, aifc meets the higher of the two. The Christian Counsellors Association of Australia (CCAA), a member association of PACFA, also recognises aifc qualifications.

Summary

aifc's courses are recognised in the following way:

- The CHC51015 Diploma of Counselling and the 10486NAT Diploma of Counselling (Christian) attains Level 1 ACA membership, and Diploma membership of CCAA.
- 10487NAT Advanced Diploma of Counselling and Family Therapy (Christian) attains CCAA Provisional Level 1 with additional hours of counselling and supervision.
- 10134NAT Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual) attains ACA membership. It also attains PACFA recognition for students who have completed all of aifc's three-year training program, including CCAA Provisional Level 2.



- Students who complete the Graduate Diploma by direct entry with a prior undergraduate course, will only be able to achieve ACA Level 1 and CCAA Provisional Level 1.
- Students are strongly encouraged to become student members of ACA or CCAA during their Diploma studies. Advanced Diploma and Graduate Diploma students are required to become members in order to help attain relevant insurances for counselling practice and for good ethical practice.

Other Courses

Master of Counselling Students:

aifc also offers a Master of Counselling for students.

It is an award accredited by the University of Divinity, delivered through a partnership with Stirling Theological College, and is not a VET course.

Entry into the Master of Counselling program requires successful completion of aifc's 10134NAT Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual). Applicants must also achieve a minimum grade requirement, attend an interview and have access to suitable clinical experience.

The course may be completed by distance from anywhere in Australia, with lectures being offered in Brisbane, Perth, Melbourne and Sydney. Students will be required to undertake clinical experience involving at least 70 hours of counselling during their studies. Students in Melbourne and/or Sydney may have access to a broader number of elective units through classroom study.

Part C: Course Delivery

What our courses involve

aifc courses emphasise personal application and growth, as well as personal equipping through training and activities. Being competency-based, our courses will train you in counselling skills and how to effectively use a counselling and family therapy model.

Student orientation

At the start of the course you will be taken through an orientation program as set out in the student orientation checklist.

This may be done face-to-face or face to screen. Some of the points covered include:

- Questions about this handbook, such as information on fees and refunds, recognition of prior learning, program orientation, student support, students' rights and responsibilities, etc.
- Information on workplace health and safety

The approximate workload for a student, over and above the time spent in formal learning (i.e. structured online classes or in seminar classes) is 20-25 hours per week for full-time study and 10-15 hours per week for part-time study which is essentially a half time load. The time required will vary between individual students based on their experience. As the courses increase with level of qualification, there is a higher expectation on students to reflect, evaluate and engage with course content.

Students studying with aifc require reasonable IT skill in order to allow them to complete and submit their course requirements. Internet connectivity at a level that is able to accommodate live-streaming of face to screen interactions is essential. A device with a webcam and microphone is required to be



able to participate in various learning opportunities. Students require word processing skills and the ability to cut and paste content, download and save documents with different names. aifc staff provide assistance at orientation for students to familiarise themselves with out IT systems, however it is recommended that students seek further external help should they not feel confident with the requirements.

Course delivery

1. VET Courses: aifc offers two delivery modes for the accredited VET courses.

Each of these delivery modes is explained below

Seminar Blended Mode

(4 x 3 day intensives plus a 1 day intensive at the end of the year for Diploma and Advanced Diploma).

Each term commences with an intensive training seminar or workshop. The training year starts on the first day of the first term. This means term one starts on the first day of the first seminar, term two starts with the second seminar and so on. The seminars are held at slightly different times in different locations, and therefore the term dates are not identical around Australia. Where possible, term dates are designed to allow for a one or two week break in the middle of the year. Please see the aifc website for seminar, VET Student Loan census dates, and details regarding your study location.

If you apply for the Seminar Blended Mode, you will be required to commit to the following:

- Detailed study of readers and other assigned textbooks.
- Attend the 3-day seminars once a term and the final assessment day in November.
- Engage with other aifc students and staff as directed by your trainer and assessor to enable you to complete your assigned tasks.
- Work with your assigned learning partner in order to complete assigned tasks and basic counselling skills exercises.
- Meet face to face with other aifc students to complete assessments.
- Complete all prescribed assessment tasks, which may be modified for individual learners as appropriate.

Your assessor will provide you with the same level of support as they do to all their students, regardless of location. In addition to the formal support available from aifc, you can set up your own supportive local learning environment by co-opting family, friends, local professionals, aifc graduates and people from your church community. As well as enhancing the quality of your learning experience, this will facilitate the learning of others involved.

Online Supported Mode (OSM)

Supported online study is an option available to all students.

It must be kept in mind that the training program is competency-based and not simply an academic exercise. It includes personal and professional skills development involving class interaction, sharing, tutorial groups, personal mentoring, demonstrations, videos, skills exercises and other activities which we adapt to be able to attain within an online program. Online Supported students are welcome to attend seminars on occasion with prior arrangement. Official commencement dates for OSM are in February and July.

If you apply for the Online Supported Mode, you will be required to commit to the following:

• Detailed study of readers and other assigned textbooks.



- Online live engagement with other aifc students and staff as directed by your trainer and assessor to enable you to complete your assigned tasks.
- Work with your assigned learning partner in order to complete assigned tasks and basic counselling skills exercises.
- Meet face to face or face to screen with other aifc students to complete assessments.
- Watch any forwarded recordings which may be sent to you on processes and unit teaching.
- Complete all online supported mode prescribed assessment tasks, which may be modified for individual learners as appropriate.
- Attend where possible the assessment day once a term at the local regional seminar location to complete any face to face assessment requirements.

Your assessor will provide you with the same level of support as they do to all their students, regardless of location. In addition to the formal support available from aifc, you can set up your own supportive local learning environment by co-opting family, friends, local professionals, aifc graduates and people from your church community. As well as enhancing the quality of your learning experience, this will facilitate the learning of others involved.

Masters course

The course (as delivered by Stirling Theological College and accredited by the University of Divinity) may be completed by distance from anywhere in Australia, with lectures being offered in Brisbane, Perth, Melbourne and Sydney. Students will be required to undertake clinical experience involving at least 70 hours of counselling during their studies. Students in Melbourne and/or Sydney may have access to a broader number of elective units through classroom study.

What do our VET courses involve?

All students will be provided with Readers, Learner Workbooks and Assessment materials for the course they are enrolled in. Access to these materials is via aifc's online learning platform. Regardless of the way you will be completing your course i.e. whether you choose OSM, or Seminar Blended Mode, you will learn in a range of ways including through:

- Interactive theory and practical classes (face to face or online) that include learning and ongoing assessment
- Tutorial sessions
- Study groups
- Working with a Learning Partner
- Self-study (reading, research, action /reflection* and completion of learning and assessment activities)

In the second half of the Advanced Diploma and Graduate Diploma courses students are required to source clients with whom to complete some counselling sessions. Student may choose to find clients through their own networks or establish themselves with a volunteer or paid placement. Aifc has partnerships in some states with organisations that offer volunteer placements for Graduate Diploma students.

Graduate Diploma Students also attend a 3 day retreat during the program.

Recognition of prior learning

Australian Institute of Family Counselling acknowledges Recognition of Prior Learning (RPL). Only whole units of competency, not portions, may be considered for RPL. Where there is a credit transfer, a non- graded assessment result for that unit may appear on an aifc Statement of Attainment or Record of Results. RPL can be requested during enrolment. Please discuss with your Regional Director and refer to the RPL Student's Guide which is available on the aifc website, or http://www.aifc.com.au/recognition-of-prior-learning/ if you are viewing this document online.

**Audit

Students may prefer to audit the course. This means that a student can attend the classes and read through the learning materials for the purpose of self enrichment or exploration of the topic, however the student will not receive any formal recognition of course completion.

Audit includes:

- A copy of the course notes
- Attending the delivery of the course (either by Seminar, Workshop or online for OSM)
- Involvement in the experiential elements of the course included in delivery (e.g. class discussion, triads etc.)
- Audit explicitly excludes:
- Assessment of work or feedback
- Involvement in assessment components of the course



Overdue Fees

Student need to pay their invoices within 14 days from the date that the invoice was issued. If you have overdue or outstanding fees at the end of each Term of study, your access to the eLearning (Moodle) system will be disabled. You will not be given access to the eLearning (Moodle) system, or be allowed to continue into your next term of study until all fees have been paid.

Non-payment of Fees

If you have a large debt with aifc, you will not be permitted to enter into another course of study until that debt is paid off. Additional, you will not receive any copies of transcripts or certificates until all debts have been paid off.

Part D: Student services and policies

Student fee protection policy

Student fees paid in advance are placed in the aifc Student Fees Trust Fund Account for security in the unlikely event of sudden termination of the training program.

Fee refund policy

The fee refund policy for students who do not wish to continue with the course is, in brief:

- The withdrawal date is the date when the Change of Enrolment Form is received by Student Services (National Office).
- Each term of study has a census date. If you withdraw before this date, the fees associated with that term (VET Student Loan or upfront payment) will be refunded or re-credited to you.
- If you withdraw after the census date, you are not eligible for a refund. Only under Special Circumstances such as a serious illness can you apply to have your VET Student Loan balance re- credited or have upfront payments refunded.
- If you intend to withdraw before the course commences, you will need to submit a completed online Change of Enrolment form (please visit http://www.aifc.com.au/policies_forms/).
- If you intend to withdraw after census date, please discuss your situation with your assessor and/or Regional Director and submit a completed online Change of Enrolment form (please visit http://www.aifc.com.au/policies_forms/).
- The above requirements do not remove your right to take further action under Australia's consumer protection laws or to seek independent legal advice and pursue other legal avenues. Attention is also drawn to the Student Complaints and Appeals policy.
- Should a course offered by aifc be cancelled prior to, or after commencement, the following applies:
- All fees paid in advance will be refunded in full.
- Where a course is cancelled, refunds will be provided within two weeks of cancellation.

Program Transfers

As part of aifc's commitment to a flexible learning environment, you have the ability to transfer in any of the following ways:

- Permanently moving from one Seminar-based location to another Seminar-based location
- Moving from a Seminar Blended Mode to the Online Supported Mode (and vice versa):
 - o A Change of Enrolment form needs to be submitted 8 weeks prior to movement
 - o You can only move once in a single course enrolment
 - o Mid-year OSM students cannot move into a Seminar-based program



- Moving from full-time study to part-time study
- Moving from part-time study to full-time study (not available after Census date of term 1)
- Each of these transfers comes with a \$200 (incl. GST) processing fee (not covered by VET Student Loans).

aifc does not offer the deferral of a course, a term of units, or single units

• The only students who are eligible to move a single unit are those who meet the "Special Circumstances" criteria (more information available on the aifc website), or those who have failed a unit and are required to study it again the following year.



Fees to redo a unit

If a student fails a unit, or withdraws from a unit after census date, they will be required to pay the full unit fee again if/when they decide to re-take the unit/s. Students accessing a VET Student Loan will not be able to utilise their VET Student Loan to cover the cost of the unit being re-taken.

Withdrawal from the course

- Students considering withdrawing from the course should first refer to the fee refund policy in this handbook. To withdraw from the course, students are required to complete an online Change of Enrolment form, available on our website, and follow carefully the process described. Student withdrawals may incur a financial penalty.
- Students are encouraged where possible to complete all assessment tasks for the current term before withdrawing. This will allow them to recommence the course at the beginning of new term in the future.

What are VET Student Loans?

VET Student Loans commenced on 1 January 2017, replacing the VET FEE-HELP scheme. The new VET Student Loans program offers greater protection for students and focuses on courses that address industry needs, creating better opportunities for employment. VET Student Loans offers income contingent loan support to eligible students studying Diploma level and above vocational education and training qualifications.

Who is Eligible?

You are eligible for VET Student Loans if you:

- Are an Australian citizen or permanent humanitarian visa holder (resident in Australia for the duration of the unit) or a New Zealand citizen with a Special Category Visa (http://studyassist.gov.au/sites/studyassist/helpfulresources/pages/faqs-nz); AND
- Have not exceeded the FEE- HELP limit (see below); AND
- Are enrolled with aifc in an eligible unit of study by the census date for that unit.

VET Student Loan Entry Requirements

All students who intend to access VET Student Loans now need to complete the "Student Entry Procedure" prior to enrolment acceptance.

Students will need to provide aifc with a copy of their Senior Secondary Certificate of Education (Year 12 certificate, completed in Australia) or display a required level of competence in both reading and numeracy. If you have not completed Year 12 or equivalent but have completed a Cert IV or above in Australia, you will need to provide aifc with appropriate documentation as evidence. If you have neither Year 12 nor Cert IV or above, you will be required to complete an online assessment to provide an analysis of your literacy and numeracy level prior to the commencement of the aifc course.

The assessment will be conducted online through the Australian Council for Educational Research's (ACER) approved Vocational, Adult and Workplace Education (VAWE) Language, Literacy and Numeracy (LLN) assessment tool.

VET Student Loans Ombudsman

The Australian Government established the new VET Student Loans program to replace the VET-FEE- HELP scheme from 1 January 2017. To complement the new program, the Australian Parliament passed the Education and Other Legislation Amendment Act (No.1) 2017

(https://www.legislation.gov.au/Details/C2017A00031/Amends). This established the VET Student Loans Ombudsman function within the Office of the Commonwealth Ombudsman to manage and investigate complaints regarding both the VET FEE-HELP scheme and the new VET Student Loans program.

The Commonwealth Ombudsman can now investigate complaints about the Vocational Education and Training (VET) Student Loans program and VET FEE-HELP scheme. If you or someone you know has an issue or complaint regarding your VET FEE-HELP or VET Student Loans training provider, you have the right to lodge a complaint with the VET Student Loan Ombudsman.

VET Student Loans Engagement and Progression

A student engagement and progression requirement applies to your continued access to a VET Student Loan. An invitation email with login details to the eCAF system will be sent to you requesting that you indicate your study intent and complete a short survey. Depending on the duration of your course and the length of time you take to complete the course, you may be requested to complete this form more than once during the length of your course. If you do not complete the form and survey, you may be ineligible to continue accessing VET Student Loans to pay for the remainder of your course tuition fees.



VET Student Loan Repayment

Your VET Student Loan debt forms part of your accumulated HELP debt. You must start repaying your Debt through the tax system when your income is above the compulsory repayment threshold which is adjusted each year. The amount you repay each year is calculated as a percentage of your total income. You can also make voluntary repayments at any time. For further information please visit www.studyassist.gov.au

Austudy/Abstudy

From the 1st of January, 2018, changes were introduced regarding student eligibility to access a Austudy/Abstudy/Centrelink payments.

For a Vocational Education Training (VET) course at Diploma level or above to be approved for a student payment, it must be a VET Student Loan (VSL) approved course and be done with a provider qualified for VSL. aifc is an approved provider of VSL, however, only our CHC51015 Diploma of Counselling and 10134NAT Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual) are approved VSL courses.

You do not need to take out a VET Student Loan to be eligible for Austudy/Abstudy/Centrelink. Your course just needs to be an approved VSL course.

Students undertaking courses that no longer meet the VSL and HELP approval criteria part-way through their course will continue to receive their student payments unless there is a break in entitlement to the payments. Gaining access to your records

All past or current students who enrolled with aifc may apply for, and receive, a copy of personal information that aifc holds in relation to the student. All requests for information must be sent in writing to studentservices@aifc.com.au. All written requests for information from current or past students must be accompanied by proof of identification, which may include their current passport



OR driver's license and their aifc Student ID card (if a current student). All requests for information from third parties must be accompanied by a declaration from the students approving the release of their personal information.

Student support

aifc staff are committed to working together with you to achieve course competency. Students in the CHC51015 Diploma, the 10486NAT Diploma and 10487NAT Advanced Diploma will be supported by an allocated assessor throughout the training program, during interviews at seminars and by personal mentoring. aifc Regional Directors are also available to assist in this. Furthermore, in the 10487NAT Advanced Diploma, you can discuss counselling issues with your counselling supervisor. Your assessor will inform you of the best time and manner to contact them. You are requested not to place unreasonable demands on your assessor or contact them at inappropriate times. Specifically, support in the CHC51015 Diploma, the 10486NAT Diploma and 10487NAT Advanced Diploma will include:

- mentoring sessions with your assessor at seminar
- attendance at mid-term studygroups
- at least one mentoring session mid-term

During enrolment or anytime throughout the students training, aifc seeks to respond to any identified student support issues through the development of a Student Support Plan (SSP) as required. The SSP identifies support needs, actions and strategies to assist and agreed responsibility to aifc or the student for the actions.

Students in the 10134NAT Graduate Diploma of Counselling and Integrated Psychotherapy (Spiritual) will be supported by a course coach, as well as other assessors.

Language, literacy and numeracy support

All new students undergo a Support Questionnaire, which will assess your Language, Literacy and Numeracy and other support needs. This will allow our staff to determine support needs and an individual Student Support Plan may be developed with you. Please note, an additional Language, Literacy and Numeracy assessment may be required if you are applying for a VET Student Loan. Students are required to reach a reasonable level of proficiency in these areas in order to complete the course.

Additional help

Students who may need additional help include, but are not limited to, those with disability, learning and language difficulties, those from other cultures, Aboriginal and Torres Straight Islanders, and South Sea Islanders. aifc is highly committed to equity and access principles to provide additional help should you need it. If necessary, course delivery and assessing methods may be modified. If you have a disability that may affect your studies, you will be asked to indicate this on your application for enrolment form and to inform your assessor at the start of the course. During the course, you are expected to seek advice, help or assistance before, rather than after, submitting assessment tasks. Individual Support Plans will be developed with students requiring additional help.

Student rights and responsibilities

As an aifc student, you have the rights and responsibilities detailed below. They are directly connected with your participation in your studies with aifc. Students have the right to:

- A good learning environment
- Receive from your assessor at the beginning of each term information on course structure, unit objectives and assessment requirements
- Undergo consistent, continuous and objective forms of assessment
- Receive an extension of time to submit work in the case of an emergency
- One free reassessment per unit
- Receive a full explanation of a result from the teacher assessing work
- Receive a regular progress report on overall performance
- Appeal against a result to your assessor or Regional Director
- Reasonable access to teachers and assessors to discuss course-related matters outside of class time
- Be free from discrimination on the basis of gender, race, family status, disability, age and beliefs
- Be free from harassment, bullying and victimisation
- Contribute to the evaluation of institute policies, practices and the course
- Learn without interference and interruption from other students
- Be taught by high quality educators who have a sound knowledge of the subject
- Learn in an environment of care, support and respect
- Copyright protection of your own work



You are responsible for:

- Ensuring that the work you submit for assessment is your own work
- Demonstrating a high standard of Christian conduct
- Following the guidelines in the Student Handbook
- Working seriously at your studies and being familiar with the information available to your course of study
- Observing attendance requirements and submitting written explanations for all absences
- Participating and cooperating in classes, tutorials and study groups
- Completing all learning activities and assessment requirements
- Maintaining strict confidentiality in relation to personal matters shared in the classroom, tutorials, study groups and in counselling
- Paying fees by the due-date
- Actively seeking learning support from teachers and assessors
- Treating fellow-students, institute staff and visiting speakers with respect
- Helping maintain aifc as a caring community
- Behaving in a responsible manner which acknowledges the rights of others as well as your own
- Wearing respectable, modest, clean and safe clothing at all times
- Respecting the property of the institute, staff and of fellow students
- Updating your personal contact details via the aifc portal
- Accepting and responding to feedback
- Applying aifc WHS policies and procedures
- Self-evaluating your work before submission
- Accepting a high degree of responsibility for the management of your online learning
- Familiarising yourself with the assessment requirements, criteria and due dates

Conduct

aifc is committed to maintaining a high standard of conduct with staff and students that is consistent with biblical and ethical standards. Misconduct includes (but is not limited to):

- disrupting the learning of others (in classroom, tutorial group, etc.)
- preventing institute staff or visiting speakers from performing their duties
- endangering the health and safety of staff or students
- any form of harassment and bullying, whether based on gender, race, age, or belief
- wilfully damaging the property of aifc staff and/or fellow students
- being under the influence of alcohol, prohibited drugs or substances
- cheating and plagiarism (see: academic honestybelow)
- making a false representation as to a matter affecting student status
- breach of rules relating to assessment
- · engaging in criminal activity

Academic honesty and dishonesty

During the online submission process, you make a declaration that the work you submit is your own and not that of any others except where acknowledged. Should you seek to gain an unfair advantage by copying other students' work, or allowing others to do their assessment tasks for them, you will be penalised. Plagiarism, this is using the work of other authors without giving credit to them, is viewed seriously in all educational organisations. Students who engage in this will be penalised. Students are



encouraged to consider that an indicator of one qualified to be a leader in the Christian community is a person who "does not pursue dishonest gain" (1 Timothy 3:8 ESV).

Disciplinary proceedings

If there is a concern or a formal complaint is received about the conduct of a student (or staff-person), the matter will be followed up as per our compliant and appeals process.

If a compliant is received against yourself will be given an opportunity to explain your behaviour and a decision will be made about what action will be taken at a meeting. If you are involved in inappropriate behaviour such as breaching standards of conduct or academic dishonesty, you can expect consequences such as:

- a verbal warning
- a formal warning (including a note on student file)
- financial penalty as described in the incidental fees
- request to redo a particular unit or component of the course
- removal from seminar or termination of access to aifc's information systems
- given a 'not yet competent' grade in a unit
- reporting to relevant authorities
- expelled from the course (indefinitely)
- suspended from the course (for a period of time or until a pre-condition is met)
- Examples of pre-conditions may include:
- Letter from relevant external source (e.g. therapist, government agency)
- Proof of access to external support such as Psychological help or IT support

Under the model legislation outlined by Safework Australia, you have a responsibility to:

- Take reasonable care for your own health and safety
- Take reasonable care that your acts or omissions do not adversely affect the health and safety of other persons
- Comply, so far as you are reasonably able, with any instruction that is given by aifc or its staff

Incidents

Should you be involved in an incident during an aifc related event (any traumatic event causing personal harm to yourself or others, such as an accident, injury, theft, damage to property, abuse, natural disaster and terrorism), you should report it to your assessor, who will complete an incident report with you and inform the aifc Regional Director who will send a copy to the Operations Manager. Any necessary actions/steps to be taken as a result of the incident will be recorded and followed up.

Student feedback (evaluation)

Feedback from students on the training program is important and taken seriously in view of the continuous improvement of the training program. If you wish to make recommendations about course improvement, you are required to submit them to your Regional Director.

Requirements to receive qualifications

- All course fees must be paid before graduation.
- To receive the Diploma of Counselling students must satisfactorily complete all the Diploma units in no more than two years (three years for Part Time students).
- To receive the Advanced Diploma of Counselling and Family Therapy (Christian) full time students must satisfactorily complete all the Advanced Diploma units in 18 months for February enrolments and no more than oneyear for Mid-Year enrolments.
- To receive the Graduate Diploma students must satisfactorily complete all the required Graduate Diploma units in no more than threeyears.
- A Statement of Attainment will be issued to those who only complete portions of the course.
 - Student's with outstanding debt will not receive a Statement of Attainment until the debt has been paid
- A graduation ceremony will be held in December each year in each seminar location. Online Supported Mode students will be invited to attend their closest location.



Certificates and Record of Results

- Upon satisfactory completion of your course and full payment of all fees you will receive a Certificate and a Record of Results listing the units that you have attained competence in.
- Additional copies of your Certificate and/or Record of Results may be obtained from the National Office at a cost of \$20 each.
- If you require any additional copies of your Certificate and/or Record of Results to be posted overseas, there will be an additional overseas postage fee applied.

Graduation ceremony

A graduation ceremony is held at the completion of each calendar year, normally in a conference room at the seminar course venue. Only students who have satisfactorily completed their relevant course and have no current debt with aifc will be awarded certificates at the ceremony. The ceremony is arranged and conducted by the Regional Director, who will give students further details as required.

There is a cost associated with attendance, approximately \$20.00 per adult, to cover the catering. You will also need to hire your graduation attire from an appropriate source. More information will be provided to you around one month before graduation.
